Pius Chong is a Managing Director and HSBC's Head of Transaction Management, Global Markets for Asia Pacific. He has responsibility for managing the execution of debt finance transactions arranged by HSBC within the Asia Pacific region including conventional and Islamic financings.

Mr Chong has been involved in the execution of some of the region's most high profile and award winning transactions for Sovereigns, quasi sovereigns, multilateral institutions, financial institutions and corporates in the international and domestic debt capital markets. His involvement in landmark Islamic financings include, executing the first internationally rated and listed global sukuk for the Government of Malaysia in 2002 that established the template for sukuk issuances. He was involved in IFC's issuance of its first Islamic securities. He also executed the sukuk issuances for Pakistan and the Republic of Indonesia.. He was a member of the core team that arranged the world's first tradable Islamic short term money market programme for the Government of Brunei. Pius was also personally involved in the first Islamic subordinated bank capital sukuk issuance by a Malaysian bank and successfully executed India's first corporate Islamic syndicated financing.

Pius Chong is the convenor of the TMA's working group on the development of Islamic finance in Hong Kong, working closely with the HKMA and market participants.

Mr Chong was the Chairman of the Debt Capital Markets Committee of the Singapore Investment Banking Association.

Pius is the co-chairman of the Credit Markets committee of the ASIFMA and an Executive committee member of the Asia Pacific Securitisation Association.

Pius was a solicitor in private practice with Freshfields Bruckhaus Deringer before joining HSBC in 2000. His principal areas of practice were debt and equity capital markets, structured finance, banking and corporate finance.

張先生是香港上海滙豐銀行有限公司(「滙豐銀行」)的執行董事及環球市場亞太區交易管理主管，負責管理該行在亞太區安排之債務融資交易的執行，包括傳統融資及伊斯蘭融資。

張先生曾參與區內多宗引人注目而又屢獲殊榮的交易，客戶包括國際及本地債務資本市場的主權國家、半主權機構、多邊機構、金融機構及商業機構等。他參與過而又具里程碑意義的伊斯蘭融資項目包括2002年為馬來西亞政府落實首宗獲國際評級及上市的全國伊斯蘭債券(sukuk)，從此為伊斯蘭債券的發行訂立了模式。他曾參與國際金融公司(IFC)的首宗伊斯蘭證券發行，也曾為巴基斯坦及印尼政府執行伊斯蘭債券的發行。他亦曾為文萊政府安排全球首項可買賣伊斯蘭短期貨幣市場計劃而成立之核心小組成員。張先生亦曾親自參與由一家馬來西亞銀行發行的首宗次級銀行資本伊斯蘭債券，並成功地落實印度首宗的伊斯蘭財團企業融資。

張先生現時是香港財資市場公會伊斯蘭金融發展工作小組的召集人，與香港金融管理局及各市場參與者一直保持緊密合作。

張先生亦曾任新加坡投資銀行協會債務資本市場委員會的主席。

他是亞洲證券業與金融市場協會(ASIFMA)信貸市場委員會的聯席主席，也是亞太證券化公會的執行委員。

在2000年加入滙豐銀行前，張先生是在富而德律師事務所(Freshfields Bruckhaus Deringer)的私人執業律師，主要業務範圍包括債務及股權資本市場、結構融資、銀行及企業融資等。
